Mental Health Diagnoses


- ▶ 30% with Schizophrenia or related thought disorders
- ▶ 40% Depressive Disorders
- ▶ 20% PTSD and Anxiety Disorders
- ▶ 10% Other Mental Health Disorders

Substance Diagnoses

- ▶ 40-50% Alcohol Dependence
- ▶ 25% Methamphetamine
- ► 20% Cocaine, Marijuana and other substances including Rx Drugs




Gender of Persons Served




Consumer Outcome Indicators

- ► Amount, types and frequency of drugs or alcohol used
- ► Medications taken as prescribed "most of the time"
- ► Reduced utilization of crisis centers, detox units, hospitals and jails
- ► Engages in services that support long term recovery
- Brief Symptom Inventory global functioning score
- ► Legal Involvement after services
- ► Housing, as appropriate for the individual




Community Support Consumers: Living Situation






Outpatient Consumers: Higher Levels of Care






Outpatient Consumers: Substance Use During Services






Outpatient Consumers: Taking Medications as Prescribed








Residential Treatment - Completion Rates



Youth Study: UNL and CenterPointe Collaborate

- 2 years of de-identified data collected from the Youth Residential Program for adolescents with co-occurring mental health and substance disorders.
- Dennis McChargue, Ph.D. Department of Psychology UNL and Graduate Research Assistant Sarah King are the Principle Investigators
- Research questions include both programmatic outcomes as well as factors that may be generalized to other youth with co occurring disorders and the programs that serve them.



UNL CenterPointe Collaboration: Research Questions

- Do adolescents use substances to self medicate for MH problems?
- How are outcomes effected by the magnitude of MH problems and/or the number of Adverse Childhood Experiences (ACE)? Childhood adversity is associated with a broad range of negative health and mental health outcomes, both in childhood and among adult survivors.
- Are there differences on outcomes among the diagnoses, substances used or other demographic elements?
- Preliminary results suggest the persons served are reporting feeling better about life and are engaged in a program of recovery and these effects increase over time (3 month post DC follow up)






Clinical Trials Network (CTN)

- ► The CTN provides an enterprise in which NIDA, treatment researchers, and community-based service providers work collaboratively
- Goals are to develop, validate, refine, and deliver new treatment options in community-level clinical practice
- Conducting studies of behavioral, pharmacological, and integrated behavioral and pharmacological treatment interventions of therapeutic effect in rigorous, multi-site clinical trials to determine effectiveness across a broad range of community-based treatment settings and diversified populations
- Ensuring the transfer of research results to physicians, clinicians, providers, and persons served in a timely way



Residential Days - Utilization






Outpatient Utilization


